## Report:

The Plan approved by Committee in 2022 for the 2022/23 year was not achieved because Covid-19 caused sessions to be cancelled, and low attendance.

MFS Committee canceled workshops from Easter onwards until Colin can produce a viable, pragmatic plan to increase attendance, reduce costs, and target break-even for the MFS.

Colin did conduct a survey in April; very low response but all wanted ECD to stay, were willing to pay more (\$10) and pay by term - but still not enough legs on the floor. No other ideas were offered to increase viability.

All Dance groups are considering options, and ECD will consider future possibilities within the whole-of-society assessment.
